The following kinds of information go in a progress note (further guidelines and examples appear below). □ counseling session start and stop times, □ medication prescription and monitoring □ the modalities and frequencies of treatment furnished, □ results of clinical

tests, and □ any summary of the following items: □ Diagnosis, □ functional status, □ symptoms, □ prognosis, and □ progress to date.

**Progress Notes and Psychotherapy Notes**

We all know documentation is a key component in the human services field. Progress notes along with other reports serve as confirmation that services were provided as indicated on the client's treatment plan. Depending on the agency or specific program, progress notes can be completed on a daily, weekly or monthly basis.

**Case Management Progress Notes**

Progress notes are partly generic in nature; for example, comments on a

patient's physical state and emotional wellbeing are likely to be appropriate whether the setting is mental health care, disability care, dementia care, or any kind of nursing context.

### **Complete Guide to Progress Notes in Disability & Aged Care ...**

Progress Notes, in other words, facts. Information that is subjective should NOT be included. Subjective information is based on assumptions or the feelings of the carer about the event or incident. Example of an objective note At approx 2.30pm, Mrs Brown was observed to have a large, red patch on her forehead above her left eyebrow.

Nursing progress notes are one of the most frequent and time consuming of nursing documentation tasks. In addition to the historical narrative notes, several other systems have been devised over the years to save time, improve documentation and standardized nursing notes. Types of progress note documentation systems include:

### **Examples & Functions of Nursing Documentation**

In the session note or progress note documentation, a change in any component of pain is worthy of documentation. Decrease in pain severity (e.g., "Pt. reports pain has

decreased to 2/10") or quality (e.g., "Pt reports pain has gone from a burning, stabbing pain to an aching pain") can be indicators of patient improvement.
