However, in order to make certain decisions - or change the constitution itself - company directors or shareholders need to pass resolutions.

Company resolution - Ordinary and special resolution

Company resolutions are legally binding decisions made by the members (shareholders or guarantors) or directors

of a limited company. They are required when formal decisions need to be made on matters beyond the scope of day-to-day business operations, such as appointing or removing a director or altering the articles of association.
