Relationship between force majeure clauses and the doctrine of frustration. Parties to a contract can agree to exclude the doctrine of frustration. A force majeure clause, which deals “ fully and completely ” with an event that would otherwise frustrate the

contract, is capable of amounting to an agreement to exclude the doctrine of frustration. However, the more catastrophic an event, the less likely it is that a force majeure clause will be taken to have dealt “ fully and completely ...

Force majeure clauses differ between contracts and a clause may not be drafted in a way which makes it operative in the current circumstances. Parties to contracts may consider looking at the doctrine of frustration to discharge their obligations under a contract.

In the absence of a force majeure clause, parties might have recourse to the common law doctrine of frustration. This provides that a party is discharged from its contractual obligations if a change in circumstances makes it physically or commercially impossible to perform the contract or would render performance radically different.

In summary, there are three main differences between frustration of contract and force majeure. First, frustration can be invoked by any party to a contract without being referred to in the contract, while force majeure must be included in a contract to be invoked.

However, force majeure is not a standalone concept of English law. Under English law, contractual performance will be excused due to unexpected circumstances only if they fall within the relatively narrow doctrine of frustration. This doctrine will apply by default unless the parties agree something else in their contract.

Force majeure/hardship clauses and frustration in English

...

Force majeure clauses generally operate so as to excuse performance of particular contractual obligations on the happening of certain specified events beyond a party’s control. Their effect is therefore usually more limited than frustration.

Frustration and force majeure | Norton Rose Fulbright

As with force majeure, frustration requires more than an event that makes performance more difficult or economically less viable. The frustrating event must have made performance impossible or transformed the obligation to perform into something radically different from what was envisaged by the parties when the contract was formed.

Coronavirus (COVID-19): is it a force majeure event?

A force majeure clause is “normally used to describe a contractual term by which one (or both) of the parties is entitled to... [be] excused from performance of the contract, in whole or in part, or is entitled to suspend performance or to claim an extension of time for performance, upon the happening of a specified event or events beyond his control [...]” (Chitty on Contracts 32nd Edition).

COVID-19: Impact on Contractual obligations - Force ...

Under English law, there is no general doctrine of “force majeure” which means the common law doctrine of frustration may apply. However, frustration only applies in limited circumstances where performance has become impossible. This uncertainty can leave many questions unanswered:

In the absence of an express force majeure clause, the common law doctrine of frustration may apply. However, frustration can be extremely difficult to establish. The doctrine of frustration will apply if: the frustrating event is not the fault of either party;

Force Majeure The literal meaning of force majeure is ‘superior force’. In the context of contract law, the phrase is used to denote intervening acts, outside of the control of the parties and beyond their reasonable contemplation, which prevents the performance of obligations under a contract.

Force Majeure and Frustration - BCR Law

Force Majeure Force majeure clauses generally provide that, upon the occurrence of a specified act, event or circumstance

which is outside of a party’s reasonable control, that party will be excused from performing part or all of its specific obligations under the contract and will not be liable for failing to perform those obligations.

Frustration and force majeure are different concepts, and it remains possible that an express force majeure clause might suspend or release contractual obligations that are made impossible – or even just more difficult or expensive – to perform as a result of Brexit. Frustration is a common law doctrine that is similar in nature to force majeure, but somewhat narrower in scope. It recognises that an event may occur through no fault of the parties, which may make a party unable to carry out its obligations under a contract.
