The Washington Lemon Law When
The Washington State Motor Vehicle "Lemon Law" is designed to help new vehicle owners who have substantial continuing problems with warranty repairs. The law allows the owner to request an arbitration hearing through the Attorney General's Office. There will be no charge for the arbitration process. At the hearing, the arbitrator will decide whether a consumer's claim meets the requirements under the law.

Lemon Law - Washington State Attorney General

The Washington State Motor Vehicle "Lemon Law" was enacted to help new vehicle owners who have substantial continuing problems with warranty repairs. The law allows the owner to request an arbitration hearing through the Lemon Law Administration of Attorney General's Office. An owner can request arbitration under Lemon Law at any time within 30 months of the vehicle's original retail delivery date.

General Lemon Law | Washington State

In Washington State there is a Lemon Law for new (and some nearly new) motor vehicles. This law (RCW 19.118.031) simply states that an owner

of a vehicle that has substantial and continuing problems with warranty repairs is entitled to an arbitration hearing through the Attorney General's Office free of charge.

Lemon Law - Washington State Attorney General

The Washington Lemon Law covers all conditions, defects, or general problems that substantially impair the use, value, or safety of your car, motorcycle, or Motor Home. You are entitled to Washington Lemon Law protection when the number of repeat repairs for the same defect or condition is unreasonable or if the total time your car is in the repair shop for warranty repair (s) is unreasonable.

Trade-in - not Lemon Law When the "lemon" is used as a trade-in on another vehicle without going through the "Lemon Law" process, the "lemon" value may be deducted from the price of the new vehicle and retail sales tax is due on the balance, if there is any. The dealer owes Retailing B&O tax on the total selling price on this type of transaction.

General Overview of Washington Lemon Laws. The term "lemon" is commonly used to describe a new automobile with a recurring problem or defect that the dealer is unable to fix. A state's lemon laws, therefore, are designed to hold

manufacturers and dealers accountable for lemons, requiring replacement or a full refund within a specified amount of time. Washington's lemon laws allow customers to receive a refund or replacement within two years or 24,000 miles after delivery.

The Magnuson-Moss Warranty Act, 15

U.S.C. §2301 et seq. (“MMWA”) is a federal law (basically a federal Lemon Law) that applies to all consumer product written warranties including Motor Vehicle and RV/Motor Home warranties. In some instances, the MMWA also incorporates State warranty law for implied warranties.

RV and Motorhome Laws: My Rights - Washington Lemon Law

The Lemon Law in the state of Washington covers “new” or “used” vehicles that were originally purchased or leased within the state and that were intended for use on public roads, including motorcycles. However, the vehicle must weigh less than 19,000 pounds and must have been covered by the vehicle manufacturer’s warranty

when sold.

arbitration hearing within 30 months of buying the vehicle to qualify. If your claim is accepted, the lemon law buyback policy states that manufacturers must replace the vehicle or repurchase it from you.

The Washington State Lemon Law defines “eligibility period” as 2 years from the original delivery or 24,000 miles of use, whichever occurs first. To seek relief under the Washington Lemon Law, a consumer who meets the law’s various requirements must send a written request to the manufacturer for a repurchase or replacement.

Consumers in Washington who have purchased or leased a new automobile with major defects are protected by Washington's Lemon Law. This law gives owners of "lemons" the remedy of a new vehicle or a refund of the vehicle purchase price, less a reasonable allowance for the use of the vehicle.
