### Income Computation And Disclosure Standards

Income Computation and Disclosure Standards (ICDS) were issued by the Government of India in exercise of powers conferred to it under section 145(2) of The Income Tax Act, 1961. The Ministry of Finance published 14 draft ICDS, out of which 10 ICDS were notified by the government on 31 March 2015. The government specified a deferment of one year from the date of implementation of these standards; the notified ICDS will be applicable from the financial year 2016-17.

Income Computation and Disclosure Standards (ICDS) Section (S.) 145 of the Income-tax Act, 1961 (ITA) provides that taxable income of an assessee falling under the heads "Profits and gains of business or profession" or "Income from other sources", shall be computed in accordance with either cash or mercantile system of accounting which is regularly employed by the assessee.

### **All about Income Computation and Disclosure Standards**

Background Section 145(1) of the Income-tax Act, 1961 (Act) stipulates that the method of accounting for computation of income under the heads "Profits and gains of business or profession" and "Income from other sources" can either be cash or mercantile system of accounting. Section 145(2) of the Act states that the Central Government may notify the accounting standards to be followed by any class of assesses or in respect of any class of income. Accordingly, two tax accounting ...

### **Presentation on Income Computation And Disclosure Standards**

This Income Computation and Disclosure Standard is applicable for computation of income chargeable under the head "Profits and gains of business or profession" or "Income from other sources" and not for the purpose of maintenance of books of accounts.

Sub-section (2) of Section 145 provides that the Central Government may notify Income Computation and Disclosure Standards (ICDS) for any class of assessees or for any class of income.

**Income Computation and Disclosure Standards (ICDS ...**

The Income Computation Disclosure Standards were notified by the Central Board of Direct Taxes (CBDT) under section 145 of the Income-tax Act, 1961 (the Act). ICDS are tax standards to be applied while computing the taxable income of a taxpayer.

**Income Computation & Disclosure Standards - Taxsutra Reservoir**

ICDS will apply for computation of taxable income under the head Profit & Gains of Business under the Income Tax Act. This is irrespective of the accounting standards i.e. either Accounting Standards or Ind-AS. The computation of book profit for MAT purpose will be as per the existing provisions of the Income Tax Act.

ICDS stands for Income Computation and Disclosure Standards. ICDS are used for computation of Income under the head PGBP and Income from Other Sources. However, accounting books shall be prepared and maintained as per the

applicable laws (such as Accounting Standards and Indian Accounting Standards as prescribed as per Companies Act, 2013).

Finally, the Central Board of Direct Taxes ("CBDT") vide Notification No. 33/2015 on March 31st 2015, i.e., after almost two decades, notified 10 Income Computation & Disclosure Standards ("ICDS"), to be effective from Assessment Year 2016-17 onwards.

**Revised Income Computation And Disclosure Standards - Tax ...**

CBDT vide its Notification No: 32/2015 dated 31-03-2015 notified 10 Income Computation and Disclosure Standards (ICDS); which are to be followed at the time of computation of income chargeable to income tax under the head "Profit and gains of business or profession" or "Income from other sources".

**Note on Income Computation and Disclosure Standards (ICDS)**

Vide Notification No. SO 892 (E) dated 31st March, 2015, Central Government notified 10 Income Computation and Disclosure Standards (ICDS). These ICDS are applicable from 1.4.2015 i.e. previous year 2015-16 (Assessment Year 2016-17).
