Mediation is a collaborative process, with emphasis on finding an

acceptable solution for both parties. Arbitration is an adversarial process, with a 'winner' and 'loser'. A mediator facilitates negotiations or discussions, but does not make any decisions. An arbitrator makes decisions based on material and evidence presented.

In mediation, the authority of decision making is with the parties with themselves, while in arbitration and litigation, a third party impose the decision because the parties are unable to find out a solution for their dispute. Arbitration is the process of resolving a dispute by an arbitrator appointed by the disputants.

Arbitration is more formal than mediation and the decision made is final but will not be made public. Arbitration fees can be high, particularly in commercial disputes, but often the cost is outweighed by the fact that the problem can be sorted quickly rather than needing many months to reach a trial.

As in a court case, there is usually a winning and a losing party in an arbitration. In a mediation, the mediator, essentially, helps parties to settle their disputes by a process of discussion and narrowing differences. The mediator helps the parties to arrive at an agreed solution. He does not decide the dispute.
