Board resolution for appointment of director of the company

This resolution can be used by choosing the category of directors to be appointed and entering all the relevant details such as the number of directors being appointed, name of the directors appointed and duration for which they are appointed. This resolution can then be incorporated in the minutes of the meeting of the Board of directors and a certified copy of the resolution can be used for the purposes of filing of e-Form DIR-12 with the Registrar of Companies.

Resolution for Re-appointment of Director Retiring by Rotation In accordance with section 152 (6) (e) of the Companies Act, 2013, the vacancy caused by the retirement of directors at an annual general meeting (AGM) may be filled in the same AGM by reappointing the retiring director (s) or appointing some other person.

Resolution for Re-appointment of Director Retiring by Rotation

A board of directors resolution (also called a "board resolution") is the result of a director vote authorizing a specific business action. Major decisions by the board of directors should always be formally documented in writing and added to the corporate record. A guide to the appointment of directors - Inform Direct

A Directors' Resolution to Appoint Director(s) and/or Acknowledge Resignation of Director(s) is a resolution passed by the directors of a company to appoint a new director, typically to fill a casual vacancy on the board. Generally, a new director must be appointed by the shareholders of a company.

Directors' Resolution to Appoint Director(s) and/or ...

Article 17 of the model articles for private limited companies allows for appointment either by the board of directors or by ordinary resolution of the shareholders. This template contains the wording that may be used when passing a shareholders' ordinary resolution to approve the appointment of one or more directors in a general meeting of shareholders.

Shareholders' Ordinary Resolution - Appointment of Directors

This Directors' Resolution document is for use when the director (s) of a company intend to pass a resolution without having a meeting. It is often referred to as a " Circular Resolution ". If the resolution is being passed at a meeting, use our Minutes of Meeting document instead.

When a director tenders his resignation from the directorship of a company, the board of directors of that company has to take note of the same through a circular resolution or in their ensuing board meeting and pass the resolution for taking note of the resignation and authorise a director or officer to file the applicable form with RoC.

Resignation of a Director in a Company: Draft Board Resolution

An order of the court confirming the resolution of the board or removing the director from office if the court is satisfied that the director is ineligible or disqualified, incapacitated, or has been negligent or derelict. A director may be appointed by the Board of Directors, unless the Memorandum requires shareholder approval.

CIPC :: Appointment, Resignation or Removal of Directors

Appointment of Directors According to the Companies Act, only an individual can be appointed as a member of the board of directors. Usually, the appointment of directors is done by shareholders. A company, association, a legal firm with an artificial legal personality cannot be appointed as a director.
