However, in 418.64 Condition of Participation: Core Services, it does state that “spiritual counseling” must be provided. While not required in the Medicare Hospice Conditions of Participation, it is important to state generally what designates a qualified and competent spiritual care provider. STANDARDS OF PRACTICE FOR HOSPICE PROGRAMS

Hospice satellite locations are also subject to survey by the State survey agency or CMS regional office. Deficiencies that are identified at any satellite location will apply to the entire hospice issued the provider agreement number. Satellite locations must comply with the hospice conditions of participation at § 418.52 through § 418.116.

Medicare and Medicaid Programs: Hospice Conditions of ...

Under the authority of section 1861(dd) of the Act, the Secretary has established the Conditions of Participation (CoPs) that a hospice must meet to participate in Medicare and/or Medicaid, and these conditions are set forth at 42 CFR part 418. The CoPs apply to a hospice as an entity as well as to the services furnished to each individual under hospice care. Under section 1861(dd) of the Act ...
