The Impact Of Investment Treaties

The impact of investment treaties on companies, shareholders and creditors Investment treaties are concluded between two or more governments and typically offer covered foreign investors protection for their investments from host government conduct in violation of the treaty such as expropriation without compensation, discrimination or treatment that is not “fair and equitable”.

Impact of Investment Treaties on Portfolio Investment The range of “investments” covered by most investment treaties is exceedingly broad, including loans, cash, debentures, contractual rights and minority shareholdings. All these assets fall outside the definition of FDI.

Investment treaties play a growing role in company life. Concluded between two or more governments, investment treaties protect covered foreign investors from certain host government conduct and abuse. Treaties typically provide protection from expropriation, discrimination or treatment that is not “fair and equitable”.

Traditionally, international investment law was conceptualised as a set of norms aiming to ensure good governance for foreign investors, in exchange for their capital and know-how. Moreover, even signing a treaty has a positive, although lower and in most specifications insignificant, effect on FDI.

The objective of investment treaties is, for the most part, the promotion and protection of foreign investment. While BITs do not preclude a host state from regulating the investment in exceptional circumstances, they primarily try to protect the investment from the arbitrary exercise of regulatory power by the host state.
