A company is considered a separate legal entity (consider it as another person), the board resolution is required for opening a bank account in addition to other documents.

Additionally, the company will have to submit other documents as well.

Board Resolution Format for Opening a New Bank Account

The bank must have proof that it has your company’s official request to open the bank account. For a corporation or LLC, you should have a corporate resolution that gives two things: the names of the company’s personnel who will sign on the account and the name of the bank where the account is to be opened.
