The Law Of Territorial Waters

Territorial waters, in international law, that area of the sea immediately adjacent to the shores of a state and subject to the territorial jurisdiction of that state. Territorial waters are thus to be distinguished on the one hand from the high seas, which are common to all countries, and on the other from internal or inland waters, such as lakes wholly surrounded by the national territory

or certain bays or estuaries.

The convention, described as a "constitution for the oceans," represents an attempt to codify international law regarding territorial waters, sea-lanes, and ocean resources. "This 106-nautical mile (nm) closing line is inconsistent with the rules of international law as reflected in the Law of the Sea Convention to enclose the waters of a bay.
